#### **Special and / or sensitive personal data that we process**

Our website and / or service does not intend to collect data about website visitors who are younger than 16 years. Unless they have permission from parents or guardians. #### **Processing personal data**

We process your personal data on the basis of the following principles and objectives:

1. Handling your payment.
2. Sending our newsletter other information.
3. You can call or e-mail us to be able to carry out our services.

5. Give you the opportunity to create an account.
6. To deliver goods and services to you.
7. Impressive BV also processes personal data if we are legally obliged to do so, such as information that we need for our tax return.

#### **Storage of data**

Nadrukkelijk BV does not store your personal data longer than is strictly necessary to achieve the purposes for which your data is collected. We keep your information as long as you are our client. This means that we keep your customer profile until you indicate that you no longer wish to use our services. If you indicate this to us, we will also consider this as a request for forgiveness. On the basis of applicable administrative obligations, we must keep invoices with your (personal) data, so we will keep this data for as long as the applicable term runs. However, employees no longer have access to your client profile and documents that we send to you have commissioned.

### **Sharing personal data with third parties**

Nadrukkelijk BV does not sell your information to third parties and only provides this information if this is necessary for the execution of our agreement with you or to comply with a legal obligation. With companies that process your data in our assignment, we conclude a processor agreement to ensure the same level of security and confidentiality of your data. Nadrukkelijk BV remains responsible for these processing operations.

### **Cookies, or similar techniques that we use**

Nadrukkelijk BV does not use cookies or similar techniques.

### **View, modify or delete data**

You have the right to view, correct or delete your personal data. You also have the right to withdraw your consent to the data processing or to object to the processing of your personal data by Nadrukkelijk BV and you have the right to data portability. This means that you can submit a request to us to send the personal information we have in your computer file to you or another organization mentioned by you. You can send a request for access, correction, deletion, data transfer of your personal data or request for withdrawal of your consent or objection to the processing of your personal data to [info@nadrukkelijkbv.nl](mailto:info@nadrukkelijkbv.nl).

To ensure that the request for access has been made by you, we ask you to send a copy of your ID with the request. Make your passport photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and citizen service number (BSN) black in this copy. This is to protect your privacy. We respond as quickly as possible, but within four weeks, at your request.
